This is to notify that Suntory Holdings Limited will be reorganizing group companies and implementing their executive appointments.

- Details -

Reorganization

Effective April 1, 2025

Reorganization of Suntory Holdings Limited

- In order to clarify the role of the Corporate Planning Division in formulating Group Management Strategy and enable it to promote that role more vigorously, it will be renamed the Corporate Strategy Division. In addition, a Corporate Strategy Department will be newly established, under the Corporate Strategy Division.
- To facilitate the Group Governance Division in promoting risk management, compliance, and legal activities that are more closely aligned with the field, and encouraging activities that are more closely integrated with those of Suntory Beverage & Food Limited, it will be renamed the GRC Division.

Reorganization of Suntory Spirits Limited

- In order to achieve a more comprehensive approach to drafting and promoting strategy for the liquor business in Japan, and to accelerate the strengthening of profit and cash management, the Business Planning Department under the Business Strategy Division will be abolished, and Business Strategy Department and Corporate Finance Planning Department will be newly established.
- Furthermore, to strengthen the promotion of BCP and risk management, as well as strengthen collaboration with Suntory Holdings Limited, the General Affairs and Risk Management Department will be renamed the General Affairs and Risk Management Planning Department.
- With the aim of conferring responsibility for the functions of planning and of the drafting and promotion of strategy within the Communication Division, as well as working to generate synergies within it, the Customer Relationship Management Department under the Communication Division will be renamed the Communication Strategy Planning & CRM Department.

- For the purpose of developing the mid-price wine market using Japanese wines, the Casual Wine Business Department under the Wine Brand Division will be renamed the Japanese Original Wine Department.
- With the intention of conferring responsibility for the drafting of strategy for the wine business as a whole, including wineries, the Winery Strategy Department under the Wine Brand Division will be renamed the Wine Strategy Department.
- In order to maintain the consistency of naming within the Wine Brand Division, the Wine Import Strategy Department will be renamed the Imported Wine Department.
- For the purpose of speeding up decision-making pertaining to overseas markets, the Liqueur/Spirits/Shochu Marketing Department 1 and Liqueur/Spirits/Shochu Marketing Department 2 under the Spirits Brand Division will be abolished, and functions for managing brands being developed for overseas markets will be transferred to the HOS Global Strategy Development Department under the Spirits Brand Division. Functions for managing brands being developed in Japan will be located in a newly established Liqueur/Spirits/Shochu Marketing Department.
- In order to strengthen the production system for casual wines, the production functions for casual wines in the Wine Production Department under the Spirits, Wine Development & Production Division will be integrated into the Spirits Production Department, which will be renamed the Spirits and Wine Production Department.
- In addition, a Japanese Wine Production Department will be newly established in the Spirits, Wine Development & Production Division for the purpose of promoting business strategy for Japanese wines and strengthening winery management, under which Tominooka Winery and Shiojiri Winery will be placed.
- With the objective of strengthening the sales structure to address the changing distribution environment, Marketing Office 5 and Marketing Office 6 will be newly established under the Nationwide Chain stores Marketing Division.

Reorganization of Suntory Wellness Limited

- In order to clarify the mission of business planning functions, the business planning functions of the Health Care Department, Skin Care Department, and Service Department will be brought together in a newly established Japan Business Planning Department. Accordingly, the names of the Health Care Department, Skin Care Department, Service Department, and Contact Center Department will be renamed the Health Care Department, Skin Care Department, Service Department, and Customer Center Department respectively.
- Following changes in the business model, the Production Department will be renamed the Production & Supply Chain Management Department to strengthen SCM functions, including those relating to supply and demand.
